1. Office of Community and Economic Development

a. 2019 Washtenaw Urban County Action Plan:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution approving the 2019 Washtenaw Urban County Plan to the U.S. Department of Housing and Urban Development (HUD) for the period of July 1, 2019 to June 30, 2020. Voice vote –motion carried.

B. Health

1. Health Department

a. Michigan Health Endowment Fund (MHEF) Grant:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution authorizing the signature of the Administrator on the grant contract from the Michigan Health Endowment Fund for the period of May 1, 2019 through April 30, 2021. Voice —motion carried.

b. Administrative Health Officer:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution approving the appointment of Jimena Loveluck, MSW as the Administrative Health Officer for the Washtenaw County Health Department effective June 24, 2019 at an annual salary of \$107,500. Voice –motion carried.

a. Modifying the Solid Waste Management Plan Amendment:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution approving modifications to the 2017 Solid Waste Management Plan Amendment and authorizing the County Administrator to send the attached letter to EGLE for approval. Voice vote –motion carried.

b. Huron River Green Infrastructure Drainage District:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution approving a pledge of the County's limited full faith and credit for payment of bonds for the Huron River Green Infrastructure Drainage District Tree Planting 5504-08 Drain Project in the amount not to exceed \$355,000.00. Voice vote —motion carried.

c. Miller's Creek Ann Arbor Drainage District:

Comm. Brabec seconded by Comm. Shink moved that the Board of Commissioners approves a resolution approving a pledge of the County's limited full faith and credit for payment of bonds for the Miller's Creek Ann Arbor Drain Drainage District in an amount not to exceed \$1,470,000.00. Voice vote —motion carried.
