The valuation information required by 211.34d, MCL is the same information needed for P.A. 5 of 1982, Section 211.24e, MCL "Truth in Taxation". A different formula is used for section 24e than is used for section 34d, but the 2008 Taxable Value, 2009 Taxable Value, Taxable Value Losses, and Taxable Value of Additions are the same quantities used in both formulas.
