#### C. Why does the CJCC exist

 Discussed historical perspective; originally developed as a result of the jail overcrowding and budget issues in the previous WCSO administration. Focus was to Improve interagency communication and cooperation, establish roles, objectives and goals and allocate resources. Bylaws were updated in 2011; CJCC was paused shortly after. CJCC was reinstated to restart in 2021.

#### D. CJCC desired outcomes

- 1. Impact based; should drive the strategies we put in place. Thoughtful and deliberate strategic planning; clearly establishing objectives and ultimate outcomes; Outcomes drives strategies drives structures; then financial piece. Identify metrics and critical data points that establish those metrics. Pre-implementation planning identify root causes, reasons for and consequences of maintaining the status quo. Solution based decisions. Also surface unintentional impacts and consequences of our work do not want to harm the folks we say we want to help. Most work we do will occur in work groups and committees. Full council will not meet as much as other committees.
