And lastly, because we are connected to EMU, we have to have our application completed and over to the Office of Research and Development within 2 weeks so that they have 14 days to go through their process of submitting the grant application. Question: The DRC has four contracts with Washtenaw County Courts only (14A, 14B, 15th, Specialty Peacemaking Court-Trial Court) for mediation programs and referral and diversion

cases - Would these be considered pre-existing contracts with the County? 2 of 4 are signed by the County Administrator so, I assume this makes us a current vendor of the County. However, from my understanding, this does not exclude us from applying, but can effect our chances of being considered for ARPA funds?

It does not exclude you, priority is being given to groups that have not previously contracted with the county, however you all seem to be in a unique situation and would just include that information in your narrative.

Question: I am writing to get some guidance and/or documentation of any limitations or requirements about indirect/facilities and administration costs for the fund listed above. Our institutional policy is to charge our full Federally negotiated rate unless there is specific requirements from the sponsor/funding agency. I believe a limited rate has been used in the past, but I want to get your input and any documentation available. I appreciate your time and assistance.

There has not been a rate set as far as I am aware for indirect costs with the goal of supporting broadest possible application of funds
