A Candidate Committee must submit the following statements in 2023 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline. Determine the schedule that applies to your committee and file the statements accordingly.

2022 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2022 Annual Statement is required to be submitted by all committees EXCEPT those that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2022 and Incumbent Judges or Justices.

^{**}Late Contribution Reports Period from: July 24-August 5, due 48 hours after receipt.

^{**}Late Contribution Reports Period from: October 23-November 4 due 48 hours after receipt.

^{**} Late contribution reports are required when \$500 or more is contributed by a single contributor during 15th to 3rd day prior to election. They are NOT waived by the reporting waiver.
