Groups are admitted on a first come, first served basis. • The Group Visit admission rate is available only to organizational groups (schools, camps, Scouts, churches, etc.) of 25 or more. • The air temperature must be 70° in order for the water park to open. We will delay opening until air temps reach 70°. • You must submit the Group Visit Form at least 1 week prior to your visit. Groups that do not submit form will be required to pay regular admission prices. • We require a minimum of 1:10 adult/student ratio. Chaperones must properly supervise children throughout the water park at all times. • When paying for your group at the water park admission booth, you do not need to wait in line with the general public. You are welcome to use the side window for group payments. • We can make a courtesy announcement when it is time for your group to leave. Please inquire at the water park office during your visit. • Outside food/beverage is not permitted in the water park, and we do not have storage for group picnic lunches or coolers. Lockers are available for personal use (\$0.50/use). • We strongly encourage groups to utilize the buddy system, and establish times and locations for buddy checks throughout your visit. • To make the most of your time, we suggest having kids come dressed to swim.
