-Ballot Question Committees-**

A Ballot Question Committee must submit the following statements in 2021 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline.

**2020 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED**

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2020 Annual Statement is required to be filed by all committees EXCEPT those committees that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2020.

File the following statements. If your committee supports or opposes a ballot proposal on a 2021 ballot, it must file a pre- and post- election statement in accordance with the election date listed below in lieu of a quarterly statement.

*April, July, and October are waived if the overlapping Pre and Post-Election CS are filed. October Statements are NOT owed in even years*

**May 4, 2021 Election:**

Pre-Election	April 18, 2021	April 23, 2021
Post-Election	May 24, 2021	June 3, 2021

**\*\*Late Contribution Reports Period from: April 19-May 1, due 48 hours after receipt.**

**August 3, 2021 Election:**

Pre-Election	July 18, 2021	July 23, 2021
Post-Election	August 23, 2021	September 2, 2021

**\*\*Late Contribution Reports Period from: July 19-July 31, due 48 hours after receipt.**

**November 2, 2021 Election:**

Pre-Election	October 17, 2021	October 22, 2021
Post-Election	November 22, 2021	December 2, 2021

**\*\*Late Contribution Reports Period from: October 18-October 30, due 48 hours after receipt.**

**\*\* Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15<sup>th</sup> to 3<sup>rd</sup> day prior to election. They are NOT waived by the reporting waiver.**
