Your committee must submit the following statements in 2021 if it participates in an election unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline. In addition to election-based filings, an Annual Statement is also required. See below.

**2020 ANNUAL CAMPAIGN FINANCE STATEMENTS REQUIRED**

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2020 Annual Statement is required to be submitted by all committees EXCEPT that that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2020.

**\*\* Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15<sup>th</sup> to 3<sup>rd</sup> day prior to election. They are NOT waived by the reporting waiver.**
